

UTV RENTAL AGREEMENT

- 1. I agree to keep UTV and equipment safe and return it in the same condition as it went out.
- 2 . I agree to pay Providence Exchange, LLC for all loss and damages incurred while the UTV is in our company's care.
- 3 . I agree to hold Providence Exchange, LLC harmless against any suits or demands incurred by reason of injuries to any persons or property caused by the use of the UTV while in our company's control. I further agree to pay all judgments, liens, or other fines or fees that may be levied against Providence Exchange, LLC and defend them at our company's expense should any of the aforementioned situations occur.
- 4. I acknowledge Providence Exchange, LLC, or their employees, are not liable for any defects in manufacturing or construction of the UTV and acknowledge that the only recourse for such defects is against the manufacturer.
- 5 . Any extension of time for the UTV must be approved by management of Providence Exchange, LLC, and amended in the contract.
- 6. Contract terminates upon return of UTV in the original condition as rented and ensuring any damages and rental fees are paid for in full by the customer.

No refunds on early returns, unless approved by Management of Providence Exchange, LLC and in writing. Requests for early refunds must be made via email or other written form.

- 7. I understand and agree to the rental fees for the UTV and equipment.
- 8. I understand that there are no verbal agreements to pricing, renting, or damages to the UTV and equipment. All terms and conditions are set forth in this contract and unless the information is included herein, and acknowledged by the customer and Providence Exchange management, there are no oral agreements.
- 9. Renter warrants that he/she has a valid driver's license.

- 10. I understand the UTV may or may not be new property.
- 11. I understand that Providence Exchange, LLC has not made or disclosed any warranty whatsoever with respect to the UTV. Renter agrees that Providence Exchange, LLC will not be liable for any damage, loss or expense of any kind caused by the UTV, its use, maintenance, or failure to be maintained.
- 12. I promise to periodically inspect the UTV to ensure it is safe to operate.
- 13. I authorize Providence Exchange, LLC to charge any and all damages to my credit card. I understand that, the original estimate is not final and that, hidden damages (not visible), or missed in the initial observation, may be included in the repair invoice and/or costs to repair the machine at a time later than the initial observation.
- 14. Renter is responsible for providing their own full coverage insurance on the machine in their possession while renting. This insurance must include any additional riders they allow to ride the machines who have not signed this agreement. Renter is responsible for any damages incurred by any person(s) outside of contract that damages machine.
- 15. I certify I have full coverage insurance (collision/comprehensive), which will cover the UTV while in transport and/or connected to the personal vehicle towing the UTV.
- 16. In the event of an automobile accident, Renter assumes all liability due to damage, bodily injury or loss of property.

I authorize Providence Exchange, LLC to charge a \$1,000 security deposit per machine, in addition to the rental charges due at the time of the rental to the credit card I have provided to them for the deposit and the rental charges. And to use this credit card for any damages incurred to UTV while in our possession and throughout the rental period identified in the rental receipt. This security deposit is in addition to charges explained in items 7, 13, 14, 15 and 16.

Anyone failing to return rented property within 72 hours after the time and date noted above, may be charged with theft and prosecuted under Colorado Criminal Code section 18-4-402, "THEFT OF RENTAL PROPERTY." Failure to return rentals valued at over \$5000 is a class 5 felony, carrying a maximum penalty of 1-9 years in the State Prison and/or fined up t o \$150,000, plus statutory surcharges.)

I agree to all the terms and conditions set forth in this Rental Agreement.
